

## Amana Brand 2019 Consumer Financing \$2,500 QuickStart Bonus – U.S. & Canada

### **Amana Brand Financing QuickStart Bonus**

With the Amana brand Financing QuickStart Bonus, we will pay a \$2,500 Bonus to each dealer that funds five qualifying transactions on Amana brand equipment through EGIA during the program period.

### **Eligible Participants and Timing:**

This program is eligible for a U.S. or Canadian licensed independent Amana Brand Heating and Air Conditioning Dealer.

- To qualify, dealer must finance five transactions of Amana brand equipment through an EGIA lender between January 1, 2019 and April 30, 2019.
- Dealer must be new to EGIA. Specifically, dealer may NOT have financed any loans on the EGIA platform (e.g. Green Sky, Wells Fargo, Enerbank, FTL, TimePayment, Foundation Finance, or Financeit) in the last 12 months.
- Dealer may select the EGIA lender of his or her choice.
- All consumer financing contracts must be funded by EGIA by May 15, 2019.
- All QuickStart Bonus claims must be submitted by May 15, 2019.

### **Qualifying Amana Equipment**

- Installation of a complete Amana brand HVAC "system" is not required. **Transaction must include at least one piece of Amana brand serialized equipment (e.g. condenser, heat pump, furnace, package unit), regardless of efficiency level.**

### **QuickStart Bonus Details:**

- To count as one of the five eligible finance contracts under this program, each finance contract must include one piece of Amana brand serialized equipment.
- Qualifying contracts must have a minimum amount financed of \$5,000 USD / \$5,000 CAD.
- Dealer must be approved and in good standing with EGIA prior to offering Amana Brand Financing Offers to Homeowners.
- All EGIA plans are subject to applicable origination fees and credit card processing fees.
- Homeowners are subject to credit approval by EGIA or their approved lenders.
- The consumer financing \$2,500 QuickStart Bonus may be combined with the previously announced Amana Brand 3% Consumer Financing Buy Down through EGIA.

### **EGIA Rebate Claims Process**

- Log on to [www.egia.org/amana](http://www.egia.org/amana) and register for the program. You will receive a set of unique logon credentials from EGIA to enter claims under this program. - All required consumer financing back-up paperwork must be sent to EGIA by the Amana Brand Dealer by submitting a claim at [https://www.egia.org/directory/partners/amana/#rebate\\_application](https://www.egia.org/directory/partners/amana/#rebate_application).
- All jobs submitted under the program must be funded by EGIA by 5/15/2019.
- Payments will be issued to the dealership and no payments will be issued to an individual, dealership employee or dealer principal.
