Which Amana brand Dealers Qualify?

To participate in the QuickStart Bonus program, an Amana brand dealer must be new to EGIA. Specifically, the dealer may NOT have financed any loans on the EGIA platforms (e.g. GreenSky, Enerbank, Foundation Finance, Mosaic, Wells Fargo, SNAP, Financeit) in the last 12 months.

STEP 1

Sign up with EGIA. If you're already signed up, you're ready for Step 2. If not, visit www.egia.org/amana for an enrollment package or call EGIA today at 888-691-0387 for more details.

STEP 2

Sell, Install and Finance 5 qualifying contracts through any EGIA lender between January 1, 2021 – April 30, 2021.

STEP 3

Submit your \$2,500 claim through EGIA's claims portal. For more details please contact an EGIA Finance Claims Program Representative at 888-691-0387 or Amana@egia.org. Claims must be submitted (funded) by May 15, 2021.

STEP 4

Enjoy your **\$2,500 QuickStart Bonus!**

What is a Qualifying Contract?

Qualifying contracts must:

- **Include at least one piece of Amana "A-Line" equipment (any efficiency level). Note that a complete Amana "system" is not required.**
- **Have a minimum amount financed of \$5,000**
- **Be contracted between January 1, 2021 – April 30, 2021 and funded by EGIA no later than May 15, 2021.**

Must meet dealer eligibility requirements. EGIA finance contracts must meet program guidelines for eligible equipment, amount financed and all EGIA requirements for documentation. Program period January 1, 2021 – April 30, 2021. Limit: One QuickStart Bonus per dealer..

Amana dealers must be signed up with EGIA's Consumer Financing program in order to take advantage of this PROMOTION.

Homeowner must purchase equipment and execute a consumer financing contract with an EGIA lender between January 1, 2021 – April 30, 2021. Licensed independent dealer must install qualifying equipment between January 1, 2021 – April 30, 2021. All consumer financing contracts must be funded by EGIA by May 15, 2021.

EGIA funding payments require no certificate of completion or paperwork. Funds are electronically transferred into the contractor's banking account within 24 – 48 hours. Credit Card processing fees may apply depending on the financial institution used for the contract. See EGIA for details. The Consumer Finance Program is separately administered by EGIA. The program is subject to change at any time at the discretion of Goodman Manufacturing or EGIA. Dealers are subject to approval by the financial institutions and Consumers are subject to credit approval.
